PS-12: Registers and use and disclosure of information held by the Registrar

1 Purpose

- 1.1 In this policy statement, the Registrar of Aboriginal and Torres Strait Islander Corporations (the Registrar) provides guidance on the use and disclosure of information held by the Registrar and his or her office. This policy statement specifies the types of information that may be made publicly available and accessible on the Registrar's website.
- 1.2 In this statement 'public registers' means the Register of Aboriginal and Torres Strait Islander Corporations and the Register of Disqualified Officers.
Note: the public registers are largely made available on the Registrar's website. However, this website does not contain all information on the public registers or all information that may be inspected by members of the public.
- 1.3 References to sections in this policy statement are references to sections of the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (the CATSI Act) unless otherwise specified. References to corporations in this policy statement are references to Aboriginal and Torres Strait Islander corporations unless otherwise specified. In addition, references in this policy statement to the Registrar are also references to a delegate who is lawfully exercising the powers of the Registrar.

2 Registers

- 2.1 Under the CATSI Act, the Registrar has to maintain public registers which contain specific information about Aboriginal and Torres Strait Islander corporations. These are:
- the Register of Aboriginal and Torres Strait Islander Corporations—section 418-1(a) and
 - the Register of Disqualified Officers—section 418-1(b).

3 Register of Aboriginal and Torres Strait Islander Corporations

- 3.1 The Register of Aboriginal and Torres Strait Islander Corporations is a public register of information and documents relating to the registration and administration of Aboriginal and Torres Strait Islander corporations. The Corporations (Aboriginal and Torres Strait Islander) Regulations 2007 (the Regulations) specify the information and documents that must be included in this register for each corporation (section 418-10 and regulation 418-10.01 and Schedule 2 of the Regulations). A table listing these documents and information is attached to this policy statement—see attachment A.

4 Register of Disqualified Officers

- 4.1 The Register of Disqualified Officers is a register of people who have been disqualified from managing Aboriginal and Torres Strait Islander corporations under sections 279-15, 279-20, 279-25 or 279-30—section 418-15(1). These provisions relate to the disqualification of a person from managing Aboriginal and Torres Strait Islander corporations by the court or the Registrar.
- 4.2 The register contains [section 418-15(2)]:
- every notice that was served under section 279-30
 - every order made by a court under sections 279-15, 279-20 or 279-25
 - every order lodged under section 279-35
 - every permission given under section 279-30(7)
 - any other document set out in the Regulations (note—at the date of this policy statement, no documents had been specified in the Regulations).
- 4.3 The Register of Disqualified Officers does not contain the details of people who have been automatically disqualified from managing Aboriginal and Torres Strait Islander corporations under section 279-5. This means that the following people are not included on the Register of Disqualified Officers:
- people who have been convicted on indictment of an offence that concerns the making of decisions that affect the whole or a substantial part of the business of an Aboriginal and Torres Strait Islander corporation or concerns an act that has the capacity to significantly affect the financial standing of a corporation—section 279-5(1)(a)
 - people who have been convicted of an offence under the CATSI Act that is punishable by imprisonment for a period greater than 12 months, or involves dishonesty and is punishable by at least three months imprisonment—section 279-5(1)(b)
 - people who have been convicted of an offence against the law of a foreign country that is punishable by imprisonment for a period greater than 12 months—section 279-5(1)(c)
 - people who are undischarged bankrupts or have a personal insolvency agreement in place—section 279-5(3) and (4)
 - people who are disqualified from managing a corporation under the *Corporations Act 2001*—section 279-5(5).

5 Information that may be obtained from the Registrar

- 5.1 The CATSI Act gives members of the public the right to:
- inspect any document lodged with the Registrar, other than exempt documents listed in attachment B—section 421-1(1)(a)

- require the Registrar to provide a copy (or extract) of any document lodged with the Registrar (other than an exempt document)—section 421-1(1)(c)
- inspect or search the Register of Aboriginal and Torres Strait Islander Corporations or the Register of Disqualified Officers—section 421-1(1)(b)
- require from the Registrar a certificate of the registration of a corporation or any other certificate authorised by the CATSI Act—section 421-1(1B)(b).

5.2 The Registrar is not required by the CATSI Act to make original documents publicly available—section 421-1(2). If the Registrar has an electronic record of a document, the Registrar may make this record available to a person who requires a copy—section 421-5.

5.3 If there are concerns about privacy, the Registrar has the power to remove personal information from any document in the public registers before a member of the public inspects it—section 421-1(1A).

6 Exempt documents

6.1 Documents which the Registrar holds, but which may not be publicly disclosed, are listed in attachment B.

7 Information on the Registrar's website

A. Information available on the public registers and the website

7.1 One of the functions of the Registrar is to make information about the registration of Aboriginal and Torres Strait Islander corporations and the administration of the CATSI Act publicly available—section 658-1(c).

7.2 The Registrar's policy is that key information on a corporation held on the Register of Aboriginal and Torres Strait Islander Corporations and the Register of Disqualified Officers, other than the exempt documents listed in attachment B, will be made available on the Registrar's website as public registers.

B. Requesting the removal of information about directors, secretaries and contact persons

7.3 Under section 330-1, corporations are required to lodge a general report that contains the names and addresses of directors, secretaries and contact persons—sections 330-5(1) and 330-10. General reports form part of the public register and are available on the Registrar's website.

7.4 Under section 304-5, corporations must lodge with the Registrar a notice of the personal details of a director, alternate director, secretary or contact person within 28 days after they are appointed. Personal details include given and family names, former given and family names, date and place of

birth, and address—section 304-5(4). Any changes in personal details of a director, secretary or contact person (including if that person ceases to be a director, secretary or contact person) must be lodged with the Registrar within 28 days of that change—section 304-5(5) and (6). Similarly, under section 304-10 directors, alternate directors, secretaries and contact persons must give that information to the corporation within 14 days of their appointment. Corporations can use the *Notification of a change to corporation officers' details* form to notify the Registrar of changes.

7.5 A corporation can ask the Registrar not to display certain information or documents on the Register of Aboriginal and Torres Strait Islander Corporations or on the website. For example, under section 304-15(2) directors, secretaries and contact persons of corporations are entitled to have an alternative address substituted for their usual residential address if:

- their name but not their residential address is on an electoral roll under the *Electoral Act 1918* (the Electoral Act) because of section 104 of the Electoral Act or
- their name is not on an electoral roll under the Electoral Act and the Registrar determines, in writing, that to include the residential address in the notice or application would put at risk their personal safety or the personal safety of members of their family.

7.6 An alternative address must be in Australia and must be a place where documents can be served on the person. The Registrar's refusal to make a determination is a reviewable decision under the CATSI Act—see 'PS-14: Review of reviewable decisions'.

C. Requesting the removal of information about members

7.7 Under section 330-1, corporations are required to lodge a general report that contains the names and addresses of members—sections 330-5(1) and 330-10. General reports form part of the public register and are available on the Registrar's website.

7.8 Members who are concerned about their address in general reports being made public on the Registrar's website should contact their corporation and request that the corporation's register of members is updated with an alternative address. Members can supply any alternative address to the corporation, which may be the corporation's address. This does not prevent the corporation from keeping a non-public mailing list separate from the register of members.

7.9 The corporation or a person aggrieved can apply to the court to have a register of members or former members corrected—section 180-40.

D. Registrar's policy—when information will be removed from the public registers

7.10 A member of the public has the right to inspect all information or documents that are part of the public registers (except exempt documents) even if this information is not published on the Registrar's website—section 421-1.

7.11 The Registrar may arrange for inspection of the information or documents in such a way that access to personal information is not provided—section 421-1(1A). In appropriate situations the Registrar may write to an individual and seek their views on disclosure of their personal information.

7.12 The Registrar will also consider requests from individuals or corporations to remove information from the public registers on a case-by-case basis, but will usually only grant the request if satisfied that:

- there are genuine concerns with making the information accessible on the public registers (such as concerns about safety, court orders, or privacy concerns about disclosing personal information)
- it is in the best interest of the corporation and its members
- the public interest in easily accessing information on an Aboriginal and Torres Strait Islander corporation will not be adversely affected.

8 Making copies of public documents

8.1 There is no fee for accessing the public registers. Copies of all documents on the public registers, or lodged with the Registrar, are free of charge, unless providing copies would substantially or unreasonably divert the resources of the Registrar's office from its other operations.

9 Information under the *Aboriginal Councils and Associations Act 1976 (ACA Act)*

9.1 Another function of the Registrar is to make documents and information relating to the registration of a corporation under the ACA Act available to the public, if the Registrar considers it appropriate. This includes documents and information that before the CATSI Act began were:

- filed or lodged with the Registrar or served on the Registrar under the ACA Act
- kept by the Registrar under the ACA Act or
- given to or served on a person by the Registrar under the ACA Act.

9.2 In determining whether it is appropriate to release information or documents relating to the registration of an Aboriginal and Torres Strait Islander corporation under the ACA Act, the Registrar will consider:

- whether the information or document would be exempt under the CATSI Act—listed in attachment B
- whether a third party gave the information to the Registrar and the information related to a particular corporation—for example, information provided by a liquidator or administrator
- whether there is a public interest or benefit in releasing the information.

9.3 The Registrar will not release information or documents which relate to a corporation under the ACA Act if they would be exempt information under the CATSI Act.

9.4 Any personal information contained in a document may be removed before its release.

10 Protected information under the CATSI Act

10.1 The CATSI Act has restrictions on how the Registrar can use and disclose information.

10.2 Information that is designated under the CATSI Act as ‘protected information’ may only be used or disclosed if specifically authorised.

10.3 Protected information is:

- all information given in confidence to the Registrar in connection with the performance or exercise of the Registrar’ functions or powers—section 604-5(1)
- all information relating to the affairs of an Aboriginal and Torres Strait Islander corporation (or related body corporate) if the information is:
 - disclosed to, or obtained by, a person, such as an examiner appointed by the Registrar under section 453-1 or
 - is included in a document given or produced to a person for the purposes of the CATSI Act—section 604-5(2).

10.4 Protected information does not include information that has been lawfully made public from other sources—section 604-5(2).

10.5 The Registrar must take all reasonable measures to prevent protected information from unauthorised use or disclosure—section 604-10.

10.6 Authorised use or disclosure of protected information includes a use or disclosure that is:

- made for the purposes of the CATSI Act—section 604-25(1)(a)
- required or authorised by a law of the Commonwealth, a state or territory—section 604-25(1)(b)
- made by the Registrar or a delegate of the Registrar in the course of the performance of a duty of the Registrar or the exercise of a power of the Registrar—section 604-25(2)(a)
- made by a person who assists the Registrar or a delegate in undertaking the performance of a duty or the exercise of a power of the Registrar—section 604-25(2)(b)
- made by a special administrator of an Aboriginal and Torres Strait Islander corporation in the course of performing a function or duty, or exercising a power as a special administrator of the corporation—section 604-25(2)(c).

10.7 The disclosure of non-exempt documents lodged with the Registrar as is required by section 421-1(1)(a) is an authorised disclosure.

10.8 The Registrar may also share protected information with the Minister and other government agencies and officers specified in section 604-25(4) and in

regulation 604-25.01. The sharing of protected information with other government agencies ensures that there is a whole-of-government approach to the monitoring and regulation of Aboriginal and Torres Strait Islander corporations.

10.9 In addition, the disclosure of:

- a summary of protected information or
- statistics derived from protected information

is an authorised disclosure of the information, but only if the summary or statistics do not identify any particular corporation or person—section 604-25(7).

A. Registrar’s policy—protected information

10.10 The Registrar may use or disclose protected information in the course of undertaking duties and functions under the CATSI Act. The Registrar may release this information to the Minister or to the government departments listed in attachment C.

10.11 On inspection of the public registers the Registrar is required to disclose non-exempt lodged documents. Only information which forms part of the public registers (other than exempt documents) will usually be released to unrelated parties who seek information about an Aboriginal and Torres Strait Islander corporation.

10.12 All other uses or disclosures of information are not authorised by the CATSI Act.

B. Registrar’s policy—confidential information

10.13 The Registrar may be given confidential information in two ways:

- voluntarily—for example, by a person making a complaint about an Aboriginal and Torres Strait Islander corporation
- under compulsion—for example, under a notice to produce documents or during the course of an examination.

10.14 The Registrar will generally treat information that is not common knowledge or has not already been publicly disclosed, as confidential whether it has been given voluntarily or under compulsion.

10.15 Information provided by whistleblowers (Part 10-5) is usually given by the whistleblower in confidence and would be protected information. Further guidance on the protection provided by the whistleblower provisions is in ‘PS-02: Complaints involving corporations’.

C. Registrar’s policy—Authorised use or disclosure of protected information—disclosures to specified agencies, departments and other bodies—section 604-25(4)

10.16 The Registrar is authorised to disclose protected information to a number of government agencies, departments and other specified bodies (section 604-25(4) and regulation 604.25.01) for the purposes set out in the CATSI Act. A table listing the bodies to which the Registrar may release protected information (and the purpose for which information may be released) is listed in attachment C.

10.17 The Explanatory Memorandum to the Corporations (Aboriginal and Torres Strait Islander) Bill 2005 provides guidance on the circumstances in which protected information may be released to other government agencies (at paragraph 5.643):

This provision allows the Registrar to share protected information consistent with the Bill or other laws, with ASIC, with Commonwealth, state or territory agencies providing funding to Aboriginal and Torres Strait Islander corporations, and provides that regulations may be made prescribing other agencies and bodies with which the Registrar may share protected information. This provision is designed to strike the balance between ensuring appropriate levels of whole-of-government monitoring and regulation, the closure of regulatory gaps that have previously existed, and the protection of an individual’s privacy.

10.18 The Registrar may impose conditions on the disclosure of protected information to an agency, department or other body listed in section 604-25(4) or in regulation 604-25.01—section 604-25(5).

10.19 A person or body to whom protected information is disclosed may only use or disclose the information they are given by the Registrar—section 604-25(6):

- for the purposes for which the information was disclosed to the recipient
- in accordance with any conditions that the Registrar has imposed on the release of information.

10.20 The Registrar may release protected information:

- voluntarily to a body specified in the CATSI Act and Regulations or
- if requested by a body specified in the CATSI Act and Regulations.

D. Protected information released on the Registrar’s volition to other government departments

10.21 Usually, the Registrar will only disclose protected information voluntarily if:

- the information is from a credible source
- has been verified
- is factually based

and

- the information discloses that there is a risk that a law of the Commonwealth or a law of a state or territory may be contravened or
- the information is for a purpose specified in the CATSI Act under section 604-25(4) or regulation 604-25.01.

E. Release of protected information by the Registrar

10.22 Before releasing protected information the Registrar will:

- determine whether the information is protected for the purposes of the CATSI Act (for example, information given in confidence, or information/documents relating to the affairs of a corporation, other than those that are included in the public registers)
- ensure the department, agency or body requesting the protected information falls within the specified bodies in the CATSI Act and Regulations—see attachment C
- ensure the information is being released for the purpose set out in the CATSI Act—see attachment C.

11 Other information

11.1 In administering the CATSI Act, the Registrar may also record or store information about an Aboriginal and Torres Strait Islander corporation that is not to be included on the public registers—for example, file notes on meetings with management or members of a corporation. This information will not be released publicly unless permitted by the Registrar. Any such disclosures must also be in line with legislative requirements, such as the provisions regulating disclosure of protected information under the CATSI Act and *Privacy Act 1988* requirements.

11.2 The Registrar may be required to release information or documents under freedom of information legislation, including information that is not stored on the public registers.
